**MINUTES OF THE REGULAR  
MEETING OF THE MAYOR AND  
BOARD OF ALDERMEN, CITY  
OF WAYNESBORO, MS.**

**BE IT THEREFORE REMEMBERED**, that the Mayor and Board of Aldermen met in a regular meeting on Tuesday, February 3, 2015 at 6:00 p.m. in the boardroom at city hall. Mayor Richard Johnson called the meeting to order. Alderman Mary Davis rendered the invocation. Present were Mayor Richard Johnson; Aldermen Mary Davis, Johnny Gray, Tammie Wilson, and Tim Cochran. Others present were City Clerk Teresa Seawright, City Attorney Curtis Bates, Police Chief Oscar Lewis, Fire Chief Willard Crocker, Assistant Fire Chief Scott Bunch, Zoning Administrator Ken Roberts, Narcotics Task Force Commander Brent Pursell, Treatment Plant Supervisor Rodney Parker, Certified Waterworks Operator Lavelle Franks, and Municipal Court Judge Charles Chapman. Alderman Shane Barnett was absent. A representative of the local media was also in attendance, as well as citizens.

**AGENDA ADOPTED**

It was moved by Alderman Davis and duly seconded by Alderman Cochran to adopt the agenda as amended. All voted aye. Motion declared carried unanimously.

**MINUTES ADOPTED**

Motion was made by Alderman Wilson and duly seconded by Alderman Gray that the minutes of the January meeting be adopted as printed. All voted aye. Motion declared carried unanimously.

**CLAIMS DOCKET APPROVED**

Upon motion of Alderman Davis and duly seconded by Alderman Cochran, the board voted unanimously to approve payment of the Claims Docket #'s 52721 through 52957, Warrant #'s 44906 through 45009 excluding Docket # 52791 and Warrant #44927 until further information is obtained. All voted aye. Motion declared carried unanimously.

#### **WAYNESBORO HOUSING AUTHORITY BOARD MEMBER REMOVED/ APPOINTED**

Motion was made by Alderman Gray and duly seconded by Alderman Davis to remove previously appointed member Joe Shanks and replace with newly appointed member Alma Powe to serve on the Waynesboro Housing Authority Board. All voted aye. Motion declared carried unanimously.

#### **CONTRACT WITH WAYNE COUNTY DIXIE YOUTH BASEBALL AND ASA SOFTBALL APPROVED**

Motion was made by Alderman Gray and duly seconded by Alderman Davis to approve a contract between the City of Waynesboro and Wayne County Dixie Youth Baseball and ASA Softball. Per said contract, the Wayne County Dixie Youth Baseball and ASA Softball program agrees to provide an organized baseball and softball program for the youth of the city and county. The city agrees to contribute the sum of \$3,000.00 to be used for said program. This action was taken after the board made a finding that the funds from the city to the Wayne County Dixie Youth Baseball and ASA Softball Program would be a benefit to the city as an advertisement purpose, and will bring into favorable notice the opportunities, possibilities and resources of the City of Waynesboro. All voted aye. Motion declared carried unanimously.

#### **CITY APPROVES DISCOUNT ON AUDITORIUM FOR PINE VIEW HEALTH CARE CENTER RELAY FOR LIFE FUND RAISER**

Motion was made by Alderman Davis and duly seconded by Alderman Cochran to approve giving Pine View Health Care Center a 50% discount on the auditorium rental fee for the use of City Auditorium for Relay for Life Fund Raiser on April 12, 2015. This action was taken after the board made a finding that said use of the auditorium would be a benefit to the city as an advertisement purpose, and will bring into favorable notice the opportunities, possibilities and resources of the City of Waynesboro. All voted aye. Motion declared carried unanimously.

#### **CITY TO CO-SPONSOR A PARENT EMPOWERMENT SESSION WITH FRIENDS OF CHILDREN OF MISSISSIPPI, INC.-BRYANT-TURNER HEAD START CENTER**

Motion was made by Alderman Wilson and duly seconded by Alderman Davis that the city co-sponsor a Parent Empowerment Session along with the Friends of Children of Mississippi, Inc., Bryant Turner Head Start Center. The event will be held at the city auditorium on February 24, 2015 at 5:00 p.m. with the city waiving all usual and customary fees for the use of the facility. The board made a finding that said use of the auditorium would be a benefit to the city as an advertisement purpose, and will bring into favorable notice the opportunities, possibilities, and resources of the City of Waynesboro. All voted aye. Motion declared carried unanimously.

**PURCHASE OF AD APPROVED FOR CITY/COUNTY MAPS (SOUTHERN ENGINEERING GPP, INC)**

Motion was made by Alderman Cochran and duly seconded by Alderman Wilson to approve the purchase of an ad from Southern Engineering GPP, Inc. in the amount of \$915.00 for advertisement on a new color city/county map and \$450.00 for five (5) 3'x 4' laminated color wall maps. This action was taken after the board made a finding that said donation would be used as an advertisement purpose, and will bring into favorable notice the opportunities, possibilities, and resources of the City of Waynesboro. All voted aye. Motion declared carried unanimously.

**EQUIPMENT DECLARED SURPLUS**

Motion was made by Alderman Davis and duly seconded by Alderman Wilson that the attached list of equipment located at City Hall and City Shed be declared surplus, and to authorize the disposal thereof as provided by state statute. All voted aye. Motion declared carried unanimously.

**RATE FOR REIMBURSEMENT OF OFFICIAL TRAVEL APPROVED**

Motion was made by Alderman Davis and duly seconded by Alderman Wilson to approve the rate for reimbursement of official travel in a private automobile to \$.575 per mile. All voted aye. Motion declared carried unanimously.

**RULES/SEWER USAGE AGREEMENT APPROVED**

Motion was made by Alderman Gray and duly seconded by Alderman Davis to approve the attached Rules/Sewer Usage Agreement which includes the issuance of permits for certified pumpers that utilize the privilege of disposing of approved waste in the City of Waynesboro's sewer system. This designated disposal site is located at 131 Turner Street. All voted aye. Motion declared carried unanimously.

**NEW METER READER SYSTEM TABLED**

There was brief discussion regarding the implementation of a new water meter reader system. This item was tabled until next month for more information to be obtained.

**INTERLOCAL GOVERNMENTAL COOPERATIVE AGREEMENT BETWEEN QUITMAN, SHUBUTA, STATE LINE, AND WAYNESBORO DISCUSSED**

After much discussion, the board instructed City Attorney Curtis Bates to prepare a new proposed Interlocal Agreement between Quitman, Shubuta, Stateline, and Waynesboro, MS with the equipment hourly rates included. No action was taken.

**CITY TREE ORDINANCE NO. T-57-90 AMENDED**

Motion was made by Alderman Cochran and duly seconded by Alderman Davis to approve the amended Ordinance providing for the location, care, topping, pruning or clearance of trees and removal of stumps, diseased and dead trees. This amended Ordinance removes all language and references to a tree board and will supercede Ordinance No. T-57-90 which was adopted on or about May 1, 1990. All voted aye. Motion declared carried unanimously.

**TASK FORCE DISCUSSED**

Task Force Commander Brent Pursell and Chief Oscar Lewis provided an update on the February 2, 2015 Task Force Meeting that was held to discuss the continuation of the division of assets between the City of Waynesboro and Greene County. No action was taken.

**MARCUS L. POUGH HIRED AS PART-TIME POLICE OFFICER**

Motion was made by Alderman Davis and duly seconded by Alderman Cochran that Marcus L. Pough be hired to the position of a part-time police officer at an hourly rate of \$12.50. Officer Pough will be placed on one (1) year probation and hiring is contingent upon successful completion of pre-employment drug screen and physical exam. All voted aye. Motion declared carried unanimously.

There being no further business at hand, motion was made by Alderman Wilson, duly seconded by Alderman Davis and unanimously approved that the meeting be adjourned.
