AN ORDINANCE PROHIBITING THE MOVEMENT OF  
HOUSES OR OTHER BUILDINGS UPON THE STREETS  
OF THE CITY OF WAYNESBORO

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE  
CITY OF WAYNESBORO, MISSISSIPPI:

SECTION 1. It shall be unlawful for any person or Corporation to move a house or other building with a width of more than 12 feet or a height of more than 15 feet from street level, into, across, or on to any street of the City of Waynesboro without posting a bond of five hundred dollars (\$500.00) with the City Clerk 10 days prior to moving said house or other building. The bond shall be accompanied by signed notification be each of the public utilities affected by the movement of said house or other building. Said bond shall remain in force until fifteen (15) days after the said house, or building has been moved and on condition said mover paying all damages to any City property caused by moving said house or building to the City Clerk.

SECTION 2. A permit to move said house or building shall be obtained by mover on payment of twenty five (\$25.00) to the City Clerk of Waynesboro, Mississippi.

SECTION 3. Anyone who shall willfully violate the said ordinance shall, upon conviction, be fined not more than three hundred dollars (\$300.00) or 1 month in jail, or both in the discretion of the courts.

The foregoing ordinance having first been reduced to writing was read and discussed, section by section, and then as a whole, and was adopted by the Mayor and the Board of Aldermen. All Aldermen present and voting "YEA" or in favor of the adoption and approval of the foregoing ordinance.

WHEREUPON, said ordinance was duly adopted and the Clerk is hereby directed to publish the same for one week in the Wayne County News and said ordinance to go into full force and effect thirty (30) days thereafter.

WHEREUPON, the Mayor declared said ordinance duly and legally adopted, and signed ordinance in open session, this the 3<sup>rd</sup> day of August, 1976.
